# Letter from Lisa

With extensive damage from the devastating tornado, the Community Foundation of Randolph County launched an ongoing emergency and disaster relief fund to help support recovery and relief efforts in Randolph County. The donation fund provides an avenue for those wishing to contribute and is set to prioritize immediate and long-term recovery and relief efforts for those impacted by the storms in Randolph County. Local volunteers are assisting us as we partner with local nonprofit agencies and local government to fully assess the situation. Recent estimates indicated the tornado left 38 injured, 1 death and it destroyed 43 structures and damaged 70 more. The tornado destruction has resulted in over \$15 million loss in assessed value in Randolph County. Through the Relief Fund, we are seeking contributions to distribute to recovery and relief efforts in Randolph County.

The Community Foundation will be in close communication with our nonprofit colleagues to ensure the funds go to relief and recovery efforts for our neighbors most affected. The Community Foundation and the all-volunteer Long-Term Recovery Committee are charged to thoughtfully determine criteria for distribution by listening to our nonprofit partners and coordinating with local government and funders. The fund's launch comes as a line of devastating storms tracked across the area the evening of March 14, producing tornados and excessive winds. The Community Foundation of Randolph County has waived the administrative fees associated with the Relief Fund. 100% of all donations received are held exclusively for tornado relief related efforts.

We appreciate every contribution and so many individuals have reached out offering support in many ways. Thank you! We have a long road to recovery, and any donations will be used to support those in need as we build back stronger.

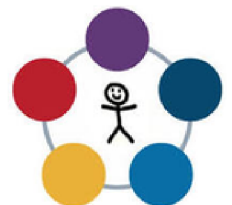

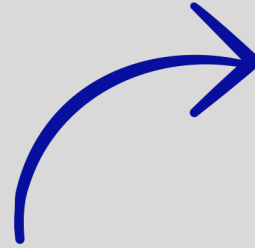
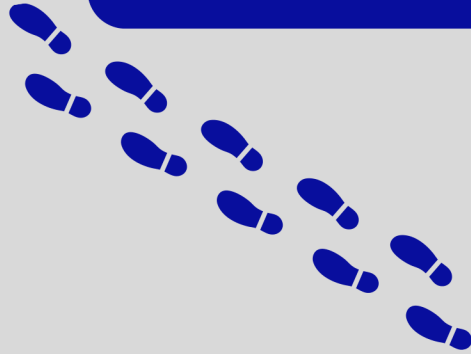


Matt Taylor

# RANDOLPH COUNTY TRAILS MASTER PLAN

## Randolph County Trails Master Plan

The Community Foundation of Randolph County (CFRC) is excited to announce the Randolph County Trails Master Plan is in its beginning stages! As a part of the Cultivating Community report, the findings inspired initiatives that are ongoing. Cultivating Community, a partnership between CFRC and Randolph County United (RCU), found five themes of improvement of the report: Housing and Blight, Drug Epidemic, Broadband Infrastructure, Education, and Quality of Life. From the report findings, outdoor recreation and healthy living were noted as improvements wanted in the county, trails being specifically mentioned. As a result, the CFRC Trails Subcommittee was formed within the Quality of Life Committee.

In January 2024, CFRC received a \$50,000 planning grant as part of the eighth phase of Lilly Endowment Inc's initiative, Giving Indiana Funds for Tomorrow (GIFT VIII). With the grant, the community foundation will develop a Master Trails Plan for Randolph County. The Master Trails Plan will provide a roadmap to the development of a trail network within the county and to connect us to surrounding regional trail systems. This is the beginning of the study process that will take place over the course of this year.

CFRC conducted an online survey receiving hundreds of responses and hosted a public open house at the Best Way Center (Husted Hall) on May 16, 2024, both of which provided great insight into how to best proceed. If you missed the chance to take that survey or attend the public open house, another opportunity for the public to learn about the progress will be at the draft plan public presentation occurring during Fall 2024.

## Max & Dianne Jones Memorial Music Lesson Scholarship Fund and Walter L. Shaw Music Lesson Scholarship Fund

The **Max & Dianne Jones Memorial Music Lesson Scholarship Fund** was established to ensure that each and every band and choir student at Winchester Community High School can participate in private music lessons. The fund provides financial assistance, based on need, to cover 50% of the cost for a private music lesson.

During the 2023-2024 school year, 91 scholarship lessons were provided.

Max Jones served the band students of Winchester Community High School from 1971 through 1983. In December 1978, Mr. Jones and the Winchester Community High School "The Force" Marching Band won the "Great Bands of the Orange Bowl" National Band Championship. The late Dianne Jones, a graduate of Winchester's Lee L. Driver High School, was a talented musician and instructor in her own right with over 30 years of impacting young vocalists and musicians.

Alumni of The Force will gather this summer to reminisce with the hope of raising money for the Jones Music Lesson Scholarship Fund to ensure support for music education at WCHS for generations to come.

Like its counterpart supporting students at Winchester Community High School, the **Walter L. Shaw Music Lesson Scholarship Fund** provides assistance to students at Union City Jr./Sr. High School. However, the Shaw Fund covers not only 9th- through 12th-grade students, but also offers the opportunity for 6th- through 8th-grade students to receive financial assistance for music lessons.

Walter Shaw served the music students of Union City West Side High School from 1937 through 1948. In 1962, Mr. Shaw received the "Music Man of the Year" award from Ball State University for excellence in contributions to public school music.

During the 2023-2024 school year, 12 scholarship lessons were provided to high school students while 66 scholarship lessons were provided to middle school students.

## Saying Goodbye

Over the last three years, so much has changed with the Promise program. When I first started working with Promise in April of 2021, the Indiana Youth Institute had just taken over as the new convener for the program statewide. We were all dealing with the pandemic and how that changed how we enrolled families into the program. However, we persevered and did as well as any county. Additionally, we saw the addition of trade schools and licensed apprenticeships to 529 eligibility.

I have enjoyed talking with families at the county fair, back to school events and parent-teacher conferences about the program and the advantages that it provides their students. I have emailed our account owners quarterly about opportunities to win contributions to their account and have kept our Facebook page active with information that may be of interest to our families.

Within the last year, Randolph County along with about two dozen other counties have decided to part ways with the Indiana Youth Institute. While some counties have decided to discontinue their program altogether, the Community Foundation of Randolph County decided to change our Promise program to an early scholarship program. While still requiring families to enroll in a 529 account, instead of contributions from the Community Foundation being sent to their 529 account the contributions will now be deposited in a scholarship fund held at the Community Foundation in their child's/children's name(s). I am excited about this change and think it will entice more families to enroll their children in the Randolph County Promise program.

As my time as coordinator comes to an end, I would like to thank Lisa Jennings and all the employees at the Community Foundation of Randolph County, both past and present, who have made this such an enjoyable experience. I would, also, like to thank Cathy Stephen-Miller who has been my sounding board and advisor for three years. Also, I would like to thank the Promise liaisons at each of the elementary schools for being the face of Promise within your community. Finally, I would like to thank the Community Foundation board for their continued support of the program.

As of June 1st, I will no longer be the Promise coordinator. My plans at this time involve more traveling with my husband, knitting, spending more time with my extended family and possibly adopting another dog.

Cultivating Community has continued

As local residents have connected through Cultivating Community sessions, one result has been the creation of Gracie's Gift, a not-for-profit organization which is highlighted below.

Earlier this year, the Randolph County Forum of Funders announced its first round of grants, awarding \$19,260. The grant recipients and projects were as follows:

- \$10,000 to **Randolph County Tourism Commission** for Come Get Mooned in Randolph County;
- \$7,660 to **Randolph County United** for a countywide community event calendar via Yodel; and
- \$1,600 to **Randolph County United** for countywide park signs.



## Gracie's Gift



**Gracie then and now**

Gracie's Gift is a 501(c)3 nonprofit organization dedicated to providing spay-neuter financial assistance to Randolph County residents. The inspiration behind our name comes from a two-week-old abandoned kitten found on a dirt trail. Low cost spay-neuter programs have been established in surrounding areas and we would like to see this important program implemented in Randolph County. We are reaching out to all residents, local businesses, and civic groups for donations to assist with our efforts. However, the following challenges still need to be addressed:

- resolving conflict in neighborhoods where cats are being fed, but neighbors no longer want the cats in their yards because the population has become overwhelming
- providing financial support for spay-neuter surgeries
- establishing a shelter in Randolph County where cats can briefly and safely be housed until surgeries are performed and recovery has taken place
- establishing partnerships with local vets willing to provide low cost spay-neuter surgeries to meet the significant demand we have received for assistance
- finding assistance with trapping and transportation to/from surgery
- promoting adoption opportunities for non-feral cats until they can transition to their forever home
- developing a base group of volunteers with the ability to serve in any of the above-mentioned areas of need
